# ADMISSIONS POLICY

## General Introduction

Stonyhurst is a co-educational day and boarding school in the Jesuit tradition. We are a Roman Catholic school and the Jesuit values upon which the College was founded in 1593 continue to underpin everything we do today. As a community we seek to do everything Ad Majorem Dei Gloriam (to the greater glory of God). Whilst we are a Catholic school, we welcome children who belong to other Christian traditions and other faiths or none and we encourage them to play a full part in the spiritual life of the school. We expect all our pupils to attend church services and school assemblies, which are fundamental to our mission and identity.

Stonyhurst provides a seamless education for children from age 3 to 18. We aim to form “men and women for others”: people who value community, who know what they stand for, and will speak up for what they believe in. One of our principal aims is for every child to feel that their contribution to school life is valued and that their special gifts are celebrated and their needs recognised.

## Information and pre-application Visits

The school prospectus and accompanying materials provide an overview of life at Stonyhurst. In our prospectus we have tried to convey something of the very special nature of a Stonyhurst education. However, it is not always possible to reflect adequately the vibrancy and warmth of the school community through the pages of a prospectus or indeed via our website. ## Structure of the school

Education at Stonyhurst is a 3 –18 continuum and comprises:

- Stonyhurst St Mary’s Hall – pupils aged 3-13
- Stonyhurst College – pupils aged 13-18

## **Application procedures and entry requirements**

Applications are welcomed for entry at all stages from age 3 to 18 and application forms can be requested from the Admissions team. Our application procedures are age appropriate and include:

- Entry assessments
- Interviews
- Character references / references from current school
- Disability assessments (if applicable)

The following information provides a general guide to the entry requirements and procedures, but Stonyhurst looks at each application on its individual merit. For any enquiries in relation to entry requirements / procedures please contact the Admissions team.

Children will be considered for entry into any year group at both Stonyhurst College and Stonyhurst St Mary's Hall

- **Entry at 3+**

Pupils can join our pre prep unit in the term that their third birthday falls. A completed application form should be submitted and where relevant, two recent school/nursery reports and a reference from the child's current school/nursery. The school offers a limited number of EAL supported places for pupils with little or no English language skills. We are no longer a registered provider of the free early education scheme (nursery vouchers). This follows the very careful consideration of a number and range of factors, the most significant being our desire to offer greater flexibility in the education of the children with regard to the sessions and timings, which best fit our timetable and our approach to teaching and learning.

We regret that we cannot generally accept children who are not potty trained, except in instances where a child has a statement of special education needs or is in the process of acquiring one. Please discuss this with us further if this is an issue.

- **Entry at 7+**

Entry into any year in KS2 is based upon the submission of the child's school reports from the previous two years, a school reference from their current school and completion of an on-line assessment. For those starting in Year 5 and above children may also be required to attend an interview ( via SKYPE if international) with the Headmaster or Head of KS2 and complete a personal information sheet along with completion of a full taster day. The school has an expert EAL support department and therefore we offer places for children with little or no English language skills

- **Entry at 11+**

Applicants for admission at the age of 11 are asked to sit an on-line entrance assessment. (This can be done remotely for international pupils) We also require submission of the child's school reports from the previous two years, a school reference from their current school, completion of a personal information sheet and to attend an interview (via SKYPE if international) with the Headmaster.

Entry into Year 8 is based upon the submission of the child's school reports from the previous two years, a school reference from their current school, completion of an on line assessment and personal information sheet and required to attend an interview (via SKYPE if international) with the Headmaster.

The school has an expert EAL support department and therefore we offer places for children with little or no English language skills.

- **Entry at 13+**

Pupils already members of the Stonyhurst community based at St. Mary's Hall will normally transfer to the College as a matter of course, but they will sit an internal assessment designed to help in placing the pupil in the correct class setting. Entry into Stonyhurst College at 13+ (Lower Grammar) from other schools is based upon interview (via SKYPE if international), school reports, and a satisfactory performance in the on-line entrance assessment.

- **Entry at 14+**

Entry into Year 10 (Grammar) is based upon interview (via SKYPE if international), school report and a satisfactory performance in the on-line entrance assessment.

- **Entry at 15+**

Entry into Year 11 (Syntax) is based upon interview (via SKYPE if international), school report and a satisfactory performance in the on-line entrance assessment.

Applications are welcomed at this stage for entry onto a structured pre-IB programme. This course may be of particular interest to overseas students looking to join the Sixth form and follow the International Baccalaureate Programme.

- **Sixth Form Entry**

Entry to the Sixth Form is based upon interview (via SKYPE if international), a satisfactory performance in the entrance examination, a satisfactory school report and performance at GCSE (or equivalent). Applicants would normally be required to have obtained a minimum of 5 Grade 6 passes at GCSE (or equivalent). Applicants for the IBCP would be expected to achieve Grade 4 passes at GCSE in Maths and English Language, together with 3 other Grade 4s at GCSE.

### **Special circumstances**

We recognise that there may be specific circumstances which affect a child's performance in an assessment test and/or interview. These may include:

- If a child is unwell when taking the test or attending for interview
- If there are particular family circumstances such as a bereavement at the time of the assessment / interview
- If there is a relevant educational history, for example an education outside the British system
- If English is not the child's first language
- If the child has a disability or specific learning difficulty

In any such special circumstance, we may ask for additional information in order to make a fair assessment.

### **Overseas Applicants**

Stonyhurst welcomes overseas pupils and has always accepted overseas applications from a wide range of countries. All overseas applicants, if they are not able to visit in person, will have a SKYPE interview to assess their ability to access the curriculum. Where required and appropriate, additional English as a second language support is made available to pupils accepted from overseas.

### **Equal Treatment**

Stonyhurst is committed to equal treatment for all, regardless of race, ethnicity, religion, sexual orientation or social background. We receive and accept applications from pupils from a diverse range of backgrounds. We believe that diversity enriches our community and is vital in preparing our pupils for today's world.

We encourage applications from anyone who feels they will benefit from a Stonyhurst education and who will be willing to contribute to, and benefit from the academic life of the school, its mission and identity and tradition. Fee support is available to make it possible for as many as possible, who meet the school's admission criteria, to attend the

school. Further details in respect of the awards for fee support can be found later in this policy.

### **Special Educational Needs**

Stonyhurst welcomes children with special educational needs. Parents/carers of children with special educational needs should discuss their child's learning needs with the school at the time of application and before he / she sits any assessment to enable the school to ensure appropriate provision is in place. We are happy to discuss thoroughly with parents/carers any adjustments that can be reasonably made for their child once they have been offered and accepted the offer of a place and before he / she becomes a pupil at the school. Parents/carers should provide, where possible, any relevant medical/psycho-educational documents that may support their child's needs. An example of this would be an Educational, Health and Care (EHC) Plan, or educational psychologist's report outlining the need for examination access arrangements. Further details of SEND provision at Stonyhurst can be found in the SEND Policy, which is available on the school website or from the school on request.

### **Disability and Accessibility**

The school Accessibility and Disability Policy and the Accessibility Plan provide an outline of Stonyhurst's current position in respect of provision for children with disabilities and also the school's plans for future provision. The documents are available on the school website and from the school on request. At present Stonyhurst has limited provision for children with disabilities but will do all that is reasonable and practicable to comply with its legal and moral responsibilities to children with disabilities who apply to the school. Stonyhurst is able to provide information about the school in other formats such as Braille and other languages, upon request.

### **Sibling Policy**

Stonyhurst welcomes the opportunity to educate the brothers and sisters of current and past pupils. However, admission is not automatic and there may be occasions where we judge that a sibling is likely to thrive better in a different educational environment. Many siblings do join us and in recognition of the incremental financial cost to families who wish to educate more than one of their children at Stonyhurst, the Governors have agreed a sliding scale of support as shown below. This reduction of fees applies whilst the children are in attendance at the same time and will be adjusted appropriately as each sibling leaves.

1 <sup>st</sup> child in attendance	0%
2 <sup>nd</sup> child in attendance	10% reduction

3 <sup>rd</sup> child in attendance	20% reduction
4 <sup>th</sup> child in attendance	30% reduction

### **Application decisions**

Stonyhurst assesses each application on its own merits taking account of the relevant entry requirements and all aspects of the admissions process. If however the school is over-subscribed has to decide between two or more candidates who meet our admission requirements after all appropriate allowances and special consideration have been given, we may give preference to:

- A child who has a brother or sister in the school or whose parent(s) attended Stonyhurst
- A child who is a practising Catholic (or whose parents are practising Catholics)
- A child applying to join as a boarder (rather than a day pupil)
- A child with a particular skill, talent or aptitude

### **Fee support**

Bursaries form the major part of the fee support offered by Stonyhurst. Fee support is intended to help pupils who are likely to benefit from a Stonyhurst education and who will contribute well to the life of the school, but whose parents cannot afford full fees.

Bursaries are means tested. Applications for fee support should be addressed to the Bursar. Any applicant applying for a scholarship who also might need fee support, should make an application for fee support at the same time as the scholarship application. The award of a scholarship will be one factor considered by the Bursary Committee in offering fee support.

The Bursary Committee carefully considers all applications on their individual merits. Details of the application process, the eligibility and selection criteria for fee support can be obtained directly from the Bursar's office.

### **Scholarships**

External applicants for scholarships should have, as a minimum, registered for a place at Stonyhurst before applying for a scholarship. External applicants for scholarships are invited to attend examinations and other assessments on the strength of school and other reports. Stonyhurst reserves the right not to call all applicants to sit for a scholarship.

At Stonyhurst College, members of Syntax playroom may be invited to sit the academic scholarship examination on recommendation of academic teachers. Not all Syntaxians who are asked to sit for a scholarship want to, and decline. There is no compulsion;

indeed, for some pupils it might be a stressful experience they are happy to do without. Neither do we offer open examinations for any Syntaxian to sit- we are mindful that it is not appropriate to offer this to everyone.

Academic, Music and Sports Scholarships are awarded on merit, at the Headmaster's discretion from age 11+. Scholarships are the highest awards offered by Stonyhurst, and the amount of scholarship awarded is decided by the Headmaster.

St Francis Xavier Awards are available to pupils aged 11+ and 13+ and are for pupils who, in the opinion of the selection panel, are most likely to benefit from, and contribute to, life at Stonyhurst. Successful candidates receive a 20% fee remission. In appropriate circumstances, this can be combined with a Bursary up to a remission maximum of 100%. Assessments for the St Francis Xavier awards take place in January and comprise a written examination and one or more interviews.

The bestowal of any scholarship carries with it privilege and responsibility. Every scholar is expected to set an example to other pupils in their conduct and approach to study, and to participate fully in the life of Stonyhurst.

The tenure of a scholarship is intended to be for the duration of the pupil's education at Stonyhurst, provided the scholarship holder's academic progress and general conduct remain satisfactory and provided the scholarship holder continues to fulfil the obligations associated with the scholarship. The monitoring of progress of scholars, and oversight of the scholars' programme of study is the responsibility of the Master of Scholars
